NOTICE OF RACE

1. Organising Authority

1.1 Organised by the Cowes Corinthian Yacht Club.

2. Rules

2.1. The Regatta will be governed by the rules as defined in World Sailing Racing Rules of Sailing 2017 – 2020.

3. Eligibility and Entry

3.1 The Boxing Day Scramble is open to all yachts and small keel boats. The race will be run under the CCYC Rating System and please supply as much as possible about the boat you are entering for this event to enable us to provide you with a rating.

3.2 There will be a prize for the best crew's fancy dress. The crews are to sail past the CCYC Marina Hammerhead between 1030 and 1040 so that they can be judged.

3.3 Outboard engines and anchors must be stored in board whilst racing.

3.4 Eligible boats may enter by completing the entry form and paying the required entry fee.

4. Fees

4.1 Entries may be made on the attached form and returned to the Secretary, Cowes Corinthian Yacht Club. The fee for the event is £15.00 per boat.

6. Sailing instructions

6.1 The Sailing instructions will be emailed to each competitor on or after 19th December 2018.

7. The Courses

7.1 The racing area will in the Central Solent starting from the CCYC, Club Line.

7.2 The course will be around the buoys using the designated marks.

7.3 The course will be announced on VHF Channel 37(M).

8. Penalties

8.1 RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

9. Radio Communications

9.1 All yachts shall carry a VHF radio.

9.2 Except in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communications that is not available to all boats.

10. Prizes

10.1 The Prizes for the Scramble will be awarded in the CCYC Clubhouse after racing.

11. Risk Statement

11.1 Rule 4 of the Racing Rules of Sailing states: 'The responsibility for a boat's decision to participate in a race or to continue racing is hers along.'

11.2 Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

11.3 They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;

11.4 They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;

11.5 They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;

11.6 Their boat is in good order, equipped to sail in the event and they are fit to participate;

11.7 The provision of a race management team, patrol boats and other officials and volunteers by the event organizer does not relieve them of their own responsibilities;

12. Insurance

12.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of £2,000,000 Sterling per incident or the equivalent.

I will ensure that no crew members race contrary to the terms of any ban imposed by World Sailing or a Nationals Authority.

I understand and agree that the information given in this race entry and results will be maintained on the Club's computer to be used for all aspects or race organisation.
